3. I will display good sportsmanship and require such of my cheerleaders, coaches, parents/family of athletes.

### BEHAVIOUR/RISK COMPLIANCE

1. I agree to follow all safety and performance rules both by the letter and spirit of the rule.
2. I agree to abide by the eligibility stipulations rules as determined by CAS and I understand that if a violation is reported, I may be required to supply eligibility verification to event officials.
3. I understand that if one or more members of our team is found to be eligible, destructive to the venue and/or competition-related property, or behaves inappropriately, our team will:
  - a. Be disqualified
  - b. Be responsible for repaying the total cost of any funds incurred as a consequence of the member(s)' actions

5. I agree to co-operate with CAS and Cheerobics officials and will follow the instructions and rules in accordance to their directions.
